

# Emergency Respite Care Grants at the Howard County Autism Society 2020-21 Application

The Emergency Respite Care Grants program at the Howard County Autism Society (HCAS) was established in October 2020 through a generous grant from Howard County, MD. Grants are intended to be utilized by individuals with autism as well as families of children, teens and adults with autism during COVID-19 to provide short-term relief for primary caregivers either at home or at a provider's facility. The maximum amount awarded is \$250 annually.

#### **Examples of Uses:**

- In-home care by a caregiver who comes to your home for a few hours, daily, weekly or as needed
- A drop-off day program that provides activities
- A respite program offered by a community-based agency, residential facility or camp
- Unplanned gap in care
- Soft supports, companion, transportation, personal care

**Financial**: While HCAS does not require proof of financial need, please bear in mind that these grants are intended for those who would otherwise have difficulty affording respite care.

Geographic: Grants are limited to residents of Howard County, MD.

**Age Requirement:** There is no age requirement for the care recipient

#### **Other Requirements**

- Care recipient cannot be residing in an institution or experiencing a medical or mental health crisis
- This is a \$250 annual grant paid directly to the respite care provider.
- Funds for respite care will be paid directly to the vendor and never to the grantee

#### **Application Procedures**

- 1. Applications for support may be made by Howard County, MD residents
- 2. One gift up to \$250 per individual or family will be awarded in a 12-month period.
- 3. If approved, the applicant will be notified by the HCAS office.
- 4. Payment will be made directly to the provider
- 5. If the application is declined, the HCAS will provide rationale for denial to the applicant.
- 6. Whenever possible, emergency requests will be decided and processed within 48 hours of receipt.
- 7. Whenever possible, other requests will be decided and processed within one week of receipt.

#### Howard County Department of Social Services - Respite Care Program

Funding available based on income level. Person receiving care must have a developmental or functional disability. Can receive Level I supervisory and personal care services (light housekeeping, meal prep, help with dressing, toileting, transferring, etc.) or Level II skilled care (monitoring vital signs, admin. Of medication, IV therapy, changing dressings, etc. Consumer/caregiver is responsible for arranging respite care and has flexibility in choosing the type of care received (inhome by an agency, neighbor, family member, friend, day care, assisted, living, camp, etc.) Consumers can receive up to 164 hours or 14 days of respite per state fiscal year. #### **Emergency Respite Care - MD Department of Human Services**

For an unplanned event that requires the unavoidable absence of the primary caregiver. Services withing 72 hours and serves across the lifespan – any age, any disability. A family may make one request per 12-month period and the maximum grant per family is \$225 per 12 month period.

#### LISS (Low Intensity Support Services) – MD Developmental Disabilities Administration

LISS may provide up to \$2000 in short-term funding for eligible children and adults with developmental disabilities who are not currently receiving services through DDA or other Medicaid waivers. Application is twice yearly – fall and spring (check website for deadlines). Utilizes a random selection application that requires basic identifying and contact information.
